IT IS ORDERED THAT unless otherwise specifically authorized by a judge, the following penalties and miscellaneous fees apply in cases before the Baton Rouge City Court:

Failure to appear (FTA) timely for court and a bench warrant and bond forfeiture is issued/contempt.....	\$100.00
Failure to appear (FTA) timely for court and a bench warrant is issued/contempt.....	\$ 50.00
Failure to appear (FTA) timely to pay a drug screen or probation supervision fee and a bench warrant is issued/contempt.....	\$ 25.00
Presentment to the court of an NSF check .....	\$ 50.00
Failure to complete community service work timely .....	\$ 20.00

• Drug Lab Analyzer .....	\$ 25.00
